2020 Annual CONGREGATIONAL MEETING

Called Meeting, on line format due to Pandemic

September 13, 2020

This Congregational Meeting was called by Reverend Jan Reynolds for the following purposes: 1. Election of Church Nominating Committee. 2. Election of Corporate Officers. 3. Nomination, ordination and installation of Deacons and Elder. The meeting, having been announced on the two previous Sundays, was conducted via Zoom.

The meeting was called to order by the moderator, Reverend Jan Reynolds, at 10:05 AM with prayer. Quorum was present.

The minutes of the last congregational meeting, having been approved by Session, were available. Minutes were approved by Common Consent.

2020-2021 Budget, approved by Session, was reviewed by Ron Moser.

Nominations of Deacons Chantal Jaycox, Mary Ratto and Keith Common were made. Nomination of Jenny Shipston as Elder was made. There were no nominations from the floor. Hand vote of majority of congregation resulted in acceptance of these Deacons and Elder. Ordination and Installation followed.

Reverend Reynolds explained the process of the annual election of Church Nominating Committee and its role in the Presbyterian Church. Two Elders, Eileen Haflich and Becky Minor agreed to serve. Nominees from the floor were Joanne Green, Chantal Jaycox, Brian Ness, Debby Ingram, and Caryn Prince. There were no more nominations from floor. Nominees were accepted by unanimous hand vote.

Pastoral Nominating Committee member, Debby Ingram, reviewed the process of finding our new pastor. Our new Pastoral Candidate will preach October 11<sup>th</sup>. A special Congregational Meeting to accept our new Pastor will follow, with Ariel Mink presiding.

Congregational Meeting was adjourned and closed with prayer by Jan at 10:55 AM.


